## Minutes of the Board of Education Meeting

June 8, 2020

1. The regular Board of Education Meeting was called to order by President Adam Naslund at 6:32 p.m. Roll call – all members were present. Adam Lambert, Donna Blocker & two guests were in attendance. President Naslund verified the posting of the Open Meetings Act, the meeting time & place.
2. It was moved by Kurt Busenitz & seconded by Betty Williams to approve the agenda as presented. Roll call vote. Motion carried 6-0.
3. President Naslund welcomed the 2 visitors to the meeting and asked if there were any comments. There were none.
4. It was moved by Betty Williams & seconded by Shannon Ravenscroft to approve the consent agenda as presented. The Board approved the minutes of the May 11, 2020 meeting. The claims in the amount of \$244,380.56 were also approved. Roll call vote. Motion carried 6-0.
